Sub : Guidelines for Selection of 3000 MW Grid-connected Solar PV Power Projects under NSM, Phase-II, Batch-II, Tranche-I, "State Specific Bundling Scheme" – Amendment, reg.

The undersigned is directed to refer to the *Guidelines for Selection of 3000 MW Grid-connected Solar PV Power Projects under NSM, Phase-II, Batch-II, Tranche-I, "State Specific Bundling Scheme"* – and to state that Section 3.5 (A) thereof stands modified as follows:

Financial Criteria</p> <p>.....</p> <p>Infusion: Minimum paid up share capital will be Rs. 1.2 crore per MW. 20% of the paid up share capital shall be infused at the time of signing of PPA and 50% at the time of Financial Closure and shall be supported with the relevant bank statements. Remaining will have to be infused before commissioning.</p> <p>.....</p>	<p>3.5 Qualification Criteria for Short-Listing of Bids/ Projects</p> <p>A. Financial Criteria</p> <p>.....</p> <p>Infusion: The SPD shall be required to demonstrate/infuse capital in the form of Equity for an amount of at least Rs. 1.2 crore/MW. This infusion shall be done @ 20% at the time of signing of PPA, 50% at the time of Financial Closure and shall be supported with the relevant bank statements. Remaining will have to be infused before commissioning.</p> <p>Share premium will form an integral part of Equity provided it is realized in cash or cash equivalent. However, this condition will not apply in case of listed Companies.</p> <p>.....</p>
