

Minutes of the Meeting for Reviewing Empanelment of Manufacturer/Suppliers and Channel Partners of CST system held on 1st July 2016, at Paryawaran Bhawan, MNRE.

The meeting of Review Committee vide office Memorandum dated 30th June 2016 for Empanelment of Manufacturer/Suppliers and Channel Partners of CST, was held on 1st July 2016 at 4 P.M. in Room no. 1029, 10th Floor Paryawaran Bhawan, CGO Complex, New Delhi under Chairmanship of Sh. Sohail Akhtar, Advisor, MNRE. Following Members participated in the meeting for assessment of applications received by MNRE.

2. The Chairman of the committee initiated meeting formally with his welcome note. Dr. Goswami, Director (CST) has briefed the Agenda of the meeting to committee members.

3. Director (CST) appraised the members about the objectives of the meeting. He mentioned that there are presently 22 Manufacturer who are empanelled with MNRE. He has also mentioned that 6 new manufacturer/ Supplier of various types of CSTs technology have been requested to include their name in the list of manufacturers/suppliers. The list of new CST manufacturers along with the technology is included in **Annexure I**.

4. The committee approved all the applications for the empanelment in principle and subject to completion of due formalities. Empanelment of M/s Luit Renewable Pvt. Ltd. was decided on the basis of their international test certificate. In addition, members specified that the company must also get their system tested within India from MNRE approved test centers. The test certificate obtained from either NISE or Savitribai Phule Pune University shall be submitted within six months from date of empanelment.

5. There were two applications of new manufacturers in Solar Cooker as given in **Annexure II**. Both of them were approved for empanelment after studying documents and information submitted by them.

6. The list of new entrepreneurs is included in **Annexure III**. Based on the incentives declared by Hon'ble Prime Minister Shri. Narendra Modi on January 16, 2016 under Start-up India movement, the committee approved exemption of the following documents and information for the empanelment.

- i. Balance Sheet for last 3 years
 - ii. Financial strength (Network, Liabilities)
 - iii. Installation experience till now (elaborate with details of the installed systems include size, configuration, design, main thermal application, performance data, clients' comments etc.)

7. It was also decided that the new entrepreneurs should strictly follow the guidelines of MNRE for installation of CST based system. New entrepreneurs need to submit all the relevant documents like test certificate, balance sheet, installation experience within two years from the date of empanelment. In addition to above, MNRE will also facilitate CST system / component test certification at the recognized test centers within India for the new entrepreneurs.

8. The committee reviewed the list of existing manufacturer/ suppliers/ channel partners in box and dish type cooker. It was unanimously decided to continue their empanelment on conditional basis of their performance in the year 2016-17.

9. Following targets were decided by the committee for all empaneled members after deliberation for the current financial year 2016-17

- i. CST channel partners shall achieve minimum of 2,000 m² installation.
- ii. CST Manufacturers/ suppliers shall achieve minimum of 1,000 m² installation
- iii. All the new entrepreneurs in CST shall achieve minimum of 500 m² installations.
- iv. Solar Cooker channel partners shall achieve minimum 1,000 Nos.
- v. Solar Cooker manufacturers shall achieve minimum 500 Nos.

10. All channel partner / manufacturer / suppliers/ new entrepreneurs will take the prior financial approval from the MNRE on the allotted targets. It was decided that individual applications received will be reviewed and sanctioned in every alternate month through PAC meeting. The last meeting of sanctioning the applications will be held on or before 15th March 2017.

11. It was decided that all the channel partner/ manufacturer/ suppliers/ new entrepreneurs will submit the consolidated details of their completed projects during the F.Y 2016-17 with or without financial assistance to MNRE on or before 30th April 2017. A review meeting will be organize in the first quarter of next F.Y 2017-18 for reviewing the continuation of empanelled manufacturer/ suppliers/ channel partners/ new entrepreneurs on the basis of their achieved targets in the previous financial year. It was decided that the manufacturer/ suppliers/ channel partners /new entrepreneurs will be delisted from the MNRE empanelment if they fails to achieve the allotted targets mentioned at point 9 and thereafter communicated to Program Division (MNRE).

The meeting ended with a vote of thanks to the chair.
