**Subject: Sanction & release of Central Financial Assistance (CFA) for installation of grid connected SPV power plants of total aggregate capacity of 2755.75 kWp to New and Renewable Energy Development Corporation of Andhra Pradesh Ltd. (NREDCAP) under the "Off Grid and Decentralized Solar Applications" scheme of MNRE.**

Sir,

In continuation to this Ministry's letter no. 5/17/2013-14/RT dated 31.12.2013 and with reference the proposals received from NREDCAP vide their various letters nos. as mentioned in Tables in Annexure, I am directed to convey sanction of President of India for installation of grid connected SPV power plants of total aggregate capacity of 2755.75 kWp to New and Renewable Energy Development Corporation of Andhra Pradesh Ltd. (NREDCAP) with the total estimated CFA of Rs.8,05,10,448/- ( Rupees Eight Crore Five lakh Ten thousand Four Hundred Forty Eight Only ) under the "Off Grid and Decentralized Solar Applications" scheme of MNRE . The details of the projects are given in annexure.

2. The cost of the project should be firmed up through competitive bidding. After the firmed up cost by competitive bidding the 30% cost acquired through competitive bidding or the CFA as proposed, whichever is lower shall be considered as eligible CFA.

3. NREDCAP has to follow all the terms and conditions already conveyed vide this Ministry's earlier sanction letter no. 5/17/2013-14/RT dated 31.12.2013 and the Administrative Approval No. 30/11/2012-13/NSM dated 26.06.2014.

4. I am also directed to sanction the release of CFA of Rs. 2,41,00,000/- (Rupees Two Crore Forty One Lakh only) to NREDCAP as 1st installment of CFA for these projects. The release of further installments will be considered after commissioning of projects and sample verification after submission of requisite claims, submission of project completion reports, utilization certificate and Audited Statement of Expenditure. For the proposals upto 5 kWp the exact address of the beneficiary, project details with project cost etc. will be submitted by the NREDCAP in the list mode duly certified by them that their individual applications, beneficiary's identification, photo and the system photographs have been kept and maintained in their office for any audit and inspection purpose.

5. The Drawing and Disbursing Officer, MNRE will draw an amount Rs. 2,41,00,000/- (Rupees Two Crore Forty One Lakh only) from the Pay & Accounts Office, MNRE and disburse the same to NREDCAP through RTGS to their bank account, as per following details:
