All the above mentioned New Entrepreneurs are hereby requested to fulfill the following recommendations:

1. The list of empanelled New Entrepreneurs will be reviewed on a quarterly basis by the committee which will be formed by MNRE.
2. The quarterly review will extensively study the contribution and performance of the New Entrepreneurs. All are advised to generate and execute minimum 500 sq. meters installation target in a year to promote CSTs, failing to meet minimum recommendations of the review meeting it will be presumed that empanelled New Entrepreneurs are not interested for the same is liable to be cancelled and delisted. Also empanelled new entrepreneurs have to take the prior financial approval from the MNRE on the allotted targets.
3. It was also decided that the new entrepreneurs should strictly follow the guidelines of MNRE for installation of CST based system. New entrepreneurs need to submit all the relevant documents like test certificate, balance sheet, installation experience within two years from the date of empanelment. All New Entrepreneurs are also advised to get their products tested and certified at the CSTs test setups in NISE, Gurgaon and UoP, Pune, within a year. Following may be contacted for this purpose:
