Sir,

I am directed to convey the approval of the President for continuation of “**Off-Grid & Decentralized Solar Applications” Scheme in the 2nd Phase of the Jawaharlal Nehru National Solar Mission during 12th Plan Period**, including following sub schemes :-

- A. Off-grid and Decentralised Solar PV Applications.
- B. Off-Grid and Decentralised Solar Thermal Application
- C. Grid-Connected Rooftop and Small Solar Power Plants Programme.
- D. Off-Grid and Decentralised Solar Cooker Programme.

The operational guidelines for implementation of the sub Schemes would be issued separately.

2. This Order is for implementation of “Off-Grid and Decentralized Solar Applications” Scheme during 2014-15 and remaining period of 12th Plan Period towards meeting the targets of the Jawaharlal Nehru National solar Mission (JNNSM).The funds for its implementation would be met from the Plan allocation made in each financial year with an overall Plan Outlay of Rs.4730 crores. The sub scheme wise Financial Outlay is given below:-


