The fourth empanelment meeting vide Office Memorandum dated 19<sup>th</sup> Septemebr 2016 for New Empanelment of Manufacturer/Suppliers and New Entrepreneurs of CST, was held on 20<sup>th</sup> Septemebr 2016 at 4 P.M. in Room no. 1029, 10<sup>th</sup> Floor Paryawaran Bhawan, CGO Complex, New Delhi under the Chairmanship of Sh. - 2. The Chairman of the committee initiated meeting formally with his welcome note. Dr. Goswami, Director (CST) has briefed the Agenda of the meeting to committee members.
- 3. Director (CST) appraised the members about the objectives of the meeting. He mentioned that there are presently 27 Manufacturers and 6 Entrepreneurs who are empanelled with MNRE for implementation of CST based system. He has also mentioned that 4 manufacturer/ supplier of various types of CSTs technology (Annexure I) and 3 new entrepreneurs have requested to include their names in the list of manufacturer/suppliers (Annexure II).
- 4. The committee has gone thoroughly with all the information submitted by new manufacturer/ suppliers of CSTs and recommended for empanelment in principle subject to completion of due formalities like CST test report and submission of the documents through state nodal agency within six months from date of empanelment. The brief information of new CST manufacturers along with the technology is formulated in tabular form and is placed at **Annexure III**. M/s 3 EN Clean Tech Pvt. Ltd., Dharwad, Karnataka has applied under new entrepreneur category but committee recommended to put them under the manufacturer category. Hence, the following manufacturer were recommended:

  - b) M/s Zodiac Energy Pvt. Ltd., Ahmedabad, Gujarat.
